

For all Guardians,

About submitting the current situation notification for FY Reiwa 8 (2026)

For those who continue using a Nursery or a Certified Childcare Center service, is required to submit a current situation notification once a year, for the verification of your childcare certification current situation. This is a very important document related to your child's childcare certification. Please make sure to submit it until the deadline.

In case of not submission, your child may be disenrolled.

(1) Deadline: September 30, 2026 (need to arrive until deadline)

※Please submit by mail directly to Nursery Division (Hoiku-ka) (Use the envelop attached in the notification)

(2) Documents to submit

Documents to be submitted by all individuals

Documents to be submitted by those who qualify (Foreigners households, or foreigner household member)

Documents to submit	Observation
④ Copy of Residence card (Back and front)	Guardians+Child (proper), Siblings, Grandparents who lives in the same household (all members)

②About the document proving that childcare can't be provided at home.

Please submit the document that correspond with your reason for needing childcare marked in black on the backside of the current situation notification on the item「2 保育を必要とする理由」for both guardians.

The item「2 保育を必要とする理由」was printed based on your current situation in July. Please use the city format for all documents.

※Those who need to make changes in the certification, please apply for the changes as soon as possible separated to this notification.

(3) About changing the certification

a. In case you need to make a change in the content printed in the current situation notification

Those who need to make a change in the content printed at the current situation notification (e.g., As household situation or childcare reason), is required an application for change. Please apply for the change until day 20 of the previous month that you want the change Applies. ※We are not accepting application for changes on this current situation notification.

b. Those who already applied for a change between July and August

【Those who applied for a change in July】

Please check if the printed information is already correct as the change applied for July And on the backside of the current situation notification, check at the box ☐無 on the item 「3 給付認定の現況確認」 and write in the parenthesis [Already changed in July].

【Those who applied for a change for August】

The current situation notification is printed according to your certification in July, but this does not require a correction.

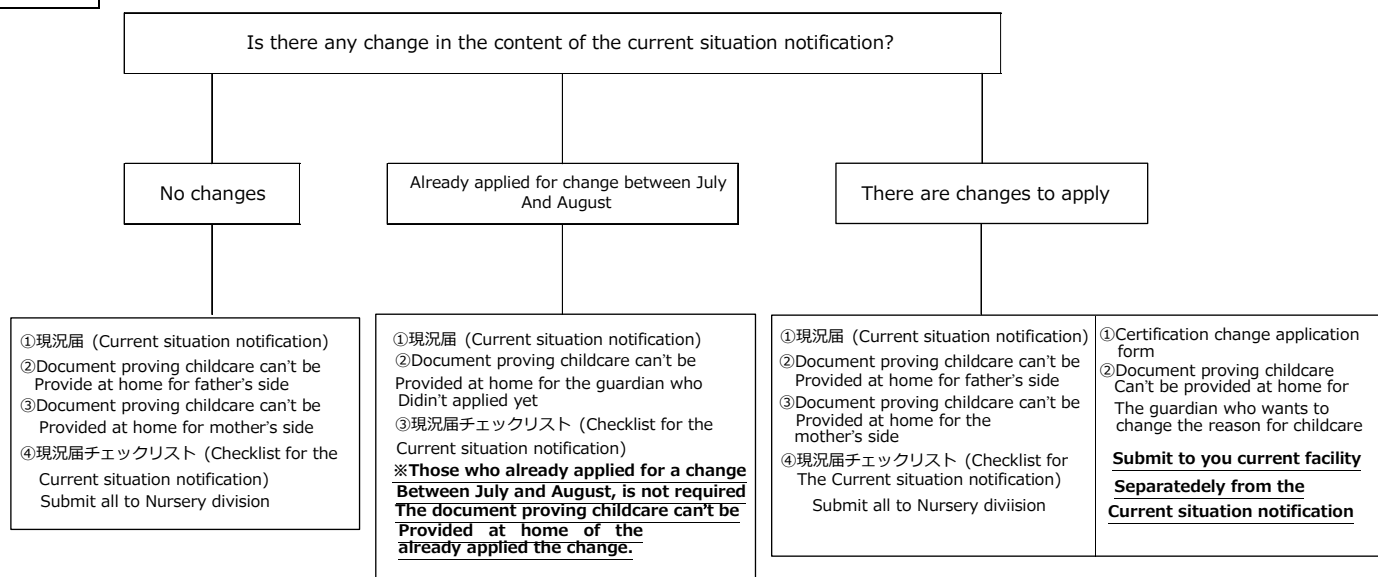
And on the backside of the current situation notification, check at the box ☐無 on the item 「3 給付認定の現況確認」 and write in the parenthesis [Already changed in August].

However, the current situation notification requires both guardians' documents. In case of one of the guardians already applied for a change, please attach only the document for the guardian who did not apply for the change and submit until the deadline September 30 by mail directly to the Nursery division.

<Example for cases who requires only document from one of guardians >

Mother already applied in July for changing the reason from Employment to Pregnancy/Childbirth, Father didn't change from employment. Father's employment certificate, current situation notification and checklist are required.
