


Child-Raising Support Payment to Help Combat Rising Cost of Living

You can receive a one-time payment of **¥20,000 per applicable child!**

■ Application

If you received this notice, typically **you do not need to apply**.

Note) if you are eligible based on "6" on the reverse of this notice, you will need to apply. If you don't wish to receive this payment, or would like to change the bank account in which you receive it, please submit a notification form to the Childcare Support Division in person or by post by Thursday, January 22, 2026 (if mailed, it must be received by this date).



1. Applicable Children (Children for Whom You Can Receive Payment)

The payment applies to the following children:

(1) Children for whom the **September 2025 (※) child allowance (Jidou Teate) payment was applicable**

(※for children born in September 2025, the October payment, instead)

(2) Children born between **October 1, 2025, and March 31, 2026**

2. Individuals Eligible to Receive Payment

An **individual receiving child allowance payments** for a child described in (1) above, or the guardian who will receive payment for a child described in (2)

3. Payment Amount

¥20,000 per eligible child (one time only).

4. Payment Date

If you received this notice, you will receive the payment on Wednesday, January 28, 2026. If you don't receive payment, please contact the Childcare Support Division (contact info on reverse). Note) If you are eligible based on "6" on the reverse you will need to apply and as a result, your payment date will be different.

5. Payment Method

(1) Child allowance recipient

Payment will be transferred to account registered for October 2025 (※) child allowance payment, or to a new account if changed via notification (Submission deadline: must be received by Thursday, January 22, 2026).

(※For children born in September 2025, the account registered at the time of the December child allowance payment, or in the event you submitted a notification to change the account receiving child allowance payments by Friday, December 26, the account after the change)

(2) Guardian who applied for child allowance (eligible based on "6" below)

Payment will be made to account you designated on your application.

Note) if payment can't be made due to the closure of or changes made to an account, please contact the Childcare Support Division by the end of March 2026.

6. Individuals Who Need to Apply to Receive Payment

The following individuals need to apply to receive payment.

Please download the application form from the city's website and submit it in person or by post to the Childcare Support Division.

Guardians of children born between October 1, 2025, and March 31, 2026, who applied for child allowance on or after December 27, 2025.

7. If You Recently Moved to Toyohashi

The city/municipality (incl. special wards) that paid your September child allowance (or, for children born in September, the October payment) will transfer money to the bank account that received that child allowance payment (or to a new account if you submitted a notification to change the account).
