

Child-Raising Support Payment to Help Combat Rising Cost of Living

You can receive a one-time payment of **¥20,000 per applicable child!**

■ Application

If you receive this notice and are eligible based on 1. below, **you must apply** to receive this payment. **Your application must be received by Tuesday, March 31, 2026 (by mail or submitted directly to the Childcare Support Division (Kosodate Shien-ka)).**

- ① This support payment notice is delivered.
- ② Fill in all necessary information on the application form and submit it to the Childcare Support Division (in person or by mail). Official **Civil servants must also include certification from the organization that employs them.** You can get the application form from the Childcare Support Division or download it from Toyohashi's official website.
- ③ Payment is transferred **to the account designated in your application.**

1. Individuals Eligible for Payment (Application Required)

Individuals for whom the following is applicable must apply:

- (1) **Civil servants** who received the September 2025 child allowance (*Jidou Teate*) payment from their employer, and who were registered residents of **Toyohashi** on September 30, 2025.
 - (2) **Civil servants** who are registered residents of **Toyohashi**, and who successfully applied to receive child allowance payments for a child born between October 1, 2025, and March 31, 2026. ※If you are not a civil servant, we will walk you through applying for this payment when you apply for child allowance
 - (3) Individuals who have fled their homes or divorced, etc., due to domestic violence from their partner, who became eligible to receive child allowance from Toyohashi on or after October 1, 2025.
※If you have fled your home due to domestic violence but your partner has already received/will receive this aid payment, you will be unable to receive it.
- 👉 **If you are not a civil servant and have not received child allowance payments due to having not completed child allowance procedures, please contact the Childcare Support Division.**

2. Payment Amount

¥20,000 per child (one time only)

3. Application Method

Please submit the following documents to the Childcare Support Division in person or by mail (you can use the enclosed return envelope).

※**To avoid congestion at City Hall, we kindly request that you mail your application.**

- (1) Application Form (civil servants must also include certification (所属庁の証明) from the organization that employs them)
- (2) A copy of bankbook (cover and page with information required for bank transfers) or cash card belonging to the applicant (must be in their name).

4. Application Deadline

Must be received by March 31, 2026

5. Payment Period

Payments will be made after applications have been reviewed and confirmed

(from the end of February 2026, in the order applications are confirmed)

We will send a notice confirming bank transfer and transfer date to applicants.

6. Payment Method

Payment will be made **to the bank account designated in your application.**

Note) If payment can't be made due to the closure of or changes made to an account, please contact the Childcare Support Division by the end of March 2026.

7. Other

■ What should I do if I moved?

Please apply through **the city/municipality (incl. special wards) at which you were a registered resident (had a valid Certificate of Residence (Juminhyou)) on September 30, 2025.** Please contact us if you have any questions or concerns.

■ Is any paperwork required in the event the Child Allowance recipient has been temporarily relocated due to a job transfer, etc?

Procedures differ depending on the city, so please contact **the city that paid the recipient's September Child Allowance.**

■ Can I receive this payment if, due to not completing an application for Child Allowance, I was ineligible for the September 2025 Child Allowance payment?

If you apply for this aid payment and it is determined you were eligible on September 30, 2025, you may be eligible to receive payment. Please contact us for more information.

■ What happens if I fled home with my child due to domestic violence?

If you are completing procedures to change your household's child allowance recipient at the city you have moved to, **you may still be eligible for this payment.** Please consult the City Hall, etc., in the city where you currently live as soon as possible. You don't need to change your registered address, and you don't need to contact the city in which your spouse resides.
