

# School Attendance Financial Aid (*Shuugaku Enjo*) Notice (2026 School Year)

## 令和8年度 就学援助制度のお知らせ

The City of Toyohashi provides financial aid (subsidies for school lunches, supplies, etc.) for eligible parents/guardians whose children are enrolled in municipal elementary and junior high schools.

### 1 Who is eligible for this financial aid?

For parents/guardians of children eligible as outlined below (see reverse for more info)

- Children who are enrolled/are scheduled to be enrolled at Toyohashi municipal elementary or junior high schools
- Children who reside in Toyohashi (according to their Certificate of Residence (*Juumin-hyou*)) and are enrolled/scheduled to be enrolled at a national elementary or prefectural junior high school
- ※ Households receiving social welfare (*Seikatsu Hogo*) will receive this aid automatically

### 2 Application Period

(1) Period : **Monday, March 2 - Sunday, March 8, 2026 (9:00 AM - 5:00 PM)**

※ **9:00 AM - 12:00 PM on Saturday, March 7 and Sunday, March 8**

(2) Location : **Toyohashi City Hall Auditorium (*Koudou*)** (Toyohashi City Hall East Building 13F)

※ Applications after the above period should be submitted to the Toyohashi City Hall School Education Division (*Gakkou Kyouiku-ka*) (Toyohashi City Hall East Building 11F)

※ Please note that **applications submitted from May 1 will result in aid being paid monthly**

### 3 Items you'll need to apply

- A parent/guardian's bankbook/bank card

※ **From the 2026 school year, financial aid payments will be made only to accounts in the name of an eligible child's parent/guardian**

※ You may be required to submit documents confirming members of household and/or household income (see reverse for more info)

### 4 Financial Aid Details (the following information is from the 2025 school year and is subject to change)

| School Trip Allowance  | Elementary Grade 6, Junior High Grade 3 | Trip by the end of July : paid at the end of August<br>Trip by the end of October : paid at the end of November<br>Trip from November onward : paid sometime after trip | You will be reimbursed for the cost of the trip if child is approved at the time of the trip (※3)  |
| Medical Fee Allowance (※4)                                   | All Grades (※5)                         | September, January, March, and April (end of each month)  | You may apply for medical treatment vouchers   |
| School Lunch   | All Grades                              | —   | Child will receive school lunches (city will cover cost)   |
| School Life Guidance and Management Form Fee Allowance (※6)  | All Grades                              | July, October, January, and April (end of each month)   | You may apply to be reimbursed for actual expenses (up to a certain limit)   |

※1 : If child is approved (or approval is revoked) after school year has begun, payments will be made monthly

※2 : If child received the Enrollment Preparation Allowance (Elementary or Junior High) during

the 2025 school year, they cannot receive the School Supplies Allowance for 1<sup>st</sup> Grade Students this year

※3 : Please note that the School Trip Allowance will not cover 100% of costs associated with the trip

※4 : Examples of things covered by medical fee allowance: decaying teeth (cavities), conjunctivitis, otitis media, chronic sinusitis, etc.

※5 : Toyohashi's subsidy system for children's medical fees (applied for through the Childcare Support Division)

takes priority over this aid for both elementary and junior high school students

※6 : You will be reimbursed for cost of completing the "School Life Guidance and Management Form"

(1) The limits for income (total income for all individuals listed on *Juumin-hyou*) are written below. However, income for parents living elsewhere (due to work transfer, etc.) is also applicable.

(2) Approval from April until June (application received by June 1) is based on income from 2024, and approval from July (application received on/after June 2) is based on 2025 income.

(3) Eligibility is confirmed monthly, so if your income changes after approval (income for applicable year), there is a chance that you will lose eligibility during the year.

(4) Please speak with us directly if you are facing unavoidable unemployment or other financial hardship.
