

# Financial Aid for single-parent households, etc.



Guardians of children who belong to private *jido* clubs (children's clubs) are eligible to receive financial aid if they meet the below requirements.

Eligibility	<p>A guardian of a child living in Toyohashi City who is a member of a private child club in Toyohashi City and who falls under ① or ② below</p> <p>① Welfare recipients</p> <p>② Single-parent households that are exempt from residence tax AND receive applicable allowances (single-parent welfare, child support, Aichi Prefecture allowances, etc.) (Relatives living together must also be exempt from the residence tax)</p> <p>※ Toyohashi will confirm the status of recipients of single-parent welfare.</p> <p>※ Tax information is necessary for application, so for those who have not yet submitted your taxes, please apply for the financial aid AFTER filing your taxes.</p>																												
Grant Amount	The maximum monthly fee is 7,000 yen (excluding August) and 10,000 yen (August) for each club.																												
Grant conditions	<p>The following conditions must be met:</p> <ul style="list-style-type: none"> <li>The club usage fee has already been paid.</li> </ul>

# Financial Aid for Siblings

**Guardians of children who belong to private *jido* clubs (children's clubs) are eligible to receive financial aid if they meet the below requirements.**

Eligibility	<p>A guardian of a child living in Toyohashi City who is a member of a private child club in Toyohashi City AND who has a sibling who is also in a private children's club.</p> <p>※ Welfare status will not be checked.</p> <p>※ Priority will be granted to those who are receiving tax exemptions and financial aid as single-parent households.</p>																					
Grant Amount	<p>Within the limits of the club usage fee,</p> <p>(1) Second person: Monthly amount of 2,000 yen (excluding August) and monthly amount of 3,000 yen (August)</p> <p>(2) Upper limit of 5,000 yen (excluding August) per month and 7,000 yen (August) per month after the third person</p>																					
Grant conditions	<p>Both of the following conditions must be met:</p> <ul style="list-style-type: none"> <li>• Siblings are in clubs at the same time (public or private)</li> <li>• The club usage fee has already been paid.</li> <li>• Enrolled in the club</li> </ul> <p>(Including children who cannot attend but are still members of the club)</p>
