

Financial Aid for single-parent households, etc.



Guardians of children who belong to private *jido* clubs (children's clubs) are eligible to receive financial aid if they meet the below requirements.

Eligibility	A guardian of a child living in Toyohashi City who is a member of a private child club in Toyohashi City and who falls under ① or ② below ① Welfare recipients ② Single-parent households that are exempt from residence tax AND receive applicable allowances (single-parent welfare, child support, Aichi Prefecture allowances, etc.) (Relatives living together must also be exempt from the residence tax) ※ Toyohashi will confirm the status of recipients of single-parent welfare. ※ Tax information is necessary for application, so for those who have not yet submitted your taxes, please apply for the financial aid AFTER filing your taxes.																								
Grant Amount	The maximum monthly fee is 7,000 yen (April to July),13,000 yen (August), 9,000 yen (September to March) for each club.																								
Grant conditions	The following conditions must be met: • The club usage fee has already been paid.

Financial Aid for Siblings

Guardians of children who belong to private *jido* clubs (children's clubs) are eligible to receive financial aid if they meet the below requirements.

Eligibility	A guardian of a child living in Toyohashi City who is a member of a private child club in Toyohashi City AND who has a sibling who is also in a private children’s club. ※ Welfare status will not be checked. ※ Priority will be granted to those who are receiving tax exemptions and financial aid as single-parent households.		
Grant Amount	Within the limits of the club usage fee, (1) Second person: Monthly amount of 2,000 yen (April to July), monthly amount of 4,000 yen (August), monthly amount of 3,000 yen (September to March) (2) Upper limit of 5,000 yen (April to July) per month, 9,000 yen (August) per month and 6,000 yen (September to March) per month after the third person		
Grant conditions	Both of the following conditions must be met: • Siblings are in clubs at the same time (public or private) • The club usage fee has already been paid. • Enrolled in the club (Including children who cannot attend but are still members of the club)
